Terms & Conditions Governing eMail Solutions

Laxmi Bank Limited (**'the Bank'**) shall provide subject to adherence of Terms and Conditions set out herein, eMail solutions.

Definitions:

In this document the following words and phrases have the meaning set below unless the context indicates otherwise:

"Account" shall mean bank account and/or credit card account and /or any other type of account so maintained by the Customer with the Bank or may be offered in future.

"Customer" shall mean a customer of the Bank or any person who has applied for any product/service of the Bank.

"Services" shall mean eMail Solutions, which include Bank's products & services, interest rates and exchange rates, information relating to customer's Account(s), details about transactions etc. and such other services as may be provided on the eMail Address by the Bank from time to time.

"eMail Address" shall mean the electronic mail address specified by the Customer at his/ her application to the Bank or otherwise for the purpose of availing the services.

"Personal Information" shall mean the information about the Customer obtained in connection with the services.

Applicability of Terms and Conditions

These terms and conditions together with the application made by the Customer and as accepted by the Bank shall form the contract between the Customer and the Bank, and shall be further subject to such terms as the Bank may agree with the other service providers.

Application

The Customer shall apply to the Bank for use of the services as per the prescribed format of the Bank.

The Bank shall endeavor to activate the services after a minimum of 1 working day from the date of receipt of the complete application.

Eligible Customer

The Customer desirous of using the services should be either a sole Account holder or authorised to act independently. In case of joint accounts, the written mandate of other account holders authorising the Customer to use the services shall be required. All or any transactions arising from the use of the services in the joint account shall be binding on all the joint account holders, jointly and severally. An Account in the name of the minor, in which a minor is a joint account holder or any account where the mode of operation is joint, is not eligible for the services.

Availability & Disclosure

The Bank shall endeavor to provide to the Customer, such services as the Bank may decide from time to time. The Bank may also make additions / deletions to the services at its sole discretion.

The Bank shall endeavor to carry out the instructions promptly provided that the Bank shall not be responsible for the delay in carrying out the instructions due to any reason whatsoever including failure of third part service provider, operational system or due to any requirement of law.

Authority to the Bank

The Customer irrevocably and unconditionally authorises the Bank to access all his Accounts for effecting banking or other transactions of the Customer through the eMail Solutions. The Customer further authorizes the Bank to share the Account information with third Parties if necessary, for the purpose of accepting/ executing request of the Customers.

Records

All records of the Bank generated by the transactions arising out of use of the services, including the time of the transaction recorded shall be conclusive proof of the genuineness and accuracy of the transactions. The authority to record the transaction details is hereby expressly granted by the Customer to the Bank.
